Public Notice

Road Traffic Regulation Act 1984, Section 1(1) 2(1) Section 14(1b), (2b) and (3) As amended by the Road Traffic Act (Temporary Restriction Act 1991) Temporary Prohibition of Use and Temporary Alteration to Traffic Flow **CARDIGAN**

Ceredigion County Council hereby gives notice that with effect from 00.01 hours on Monday the 13th day of July 2020, no vehicle shall proceed along the lengths of road in Cardigan as mentioned in Schedule 1 of this Notice. No vehicle shall park, load or wait along the lengths of road as mentioned in Schedule 1 and 2 of this Notice. Vehicles shall only travel along roads in the direction as mentioned in Schedule 3 of this Notice. Vehicles will only be able to park or wait as mentioned in Schedule 4 of this Notice. This Temporary Prohibition of Use will remain in force for the duration of this Notice. Pedestrian access will be maintained at all times. Restrictions will **not** apply between 18:01and 10.59 hours.

Schedule 1. Temporary Prohibition of Traffic between 11:00 and 18:00 hours daily:

High Street: from the Shire Hall to the junction with College Row.

Pendre: from the junction with College Row to the junction with Bathhouse Road.

Market Lane: from the junction with High Street to junction with Middle Mwldan. from the junction with High Street to the junction with Morgan Street. St. Mary Street: **Ebens Lane:** from the junction with High Street to the junction with Middle Mwldan. **Chancery Lane:** from the junction with High Street to the junction with St. Mary Street.

from the junction with High Street to 'Beauty in Motion'. Pwllhai:

from the junction with High Street/Pendre to the junction with Middle **College Row:**

Mwldan.

Priory Street: from Priory Court to the junction with Pendre.

Upper Mwldan: whole length of access road running from the back of the Guild Hall.

College Row junction, to the footway on Bathhouse Road.

William Street: from the junction with Feidrfair to the junction with Pendre.

Bathhouse Road: from the Theatre junction of Bathhouse Road to the junction with Llys

Owen.

Schedule 2. Temporary Prohibition of Parking, Waiting and Loading between 11:00 and 18:00 hours daily:

All parking bays, street parking and loading along the roads mentioned in **Schedule 1** of this Notice will be prohibited during the periods of road closure.

Schedule 3. Temporary Alteration to Traffic Flow between 11:00 and 18:00 hours daily:

Greenfield **one-way** traffic flow travelling in a north-easterly direction, from the junction

with Middle Mwldan/College Row to junction with Greenfield Row. Square:

Priory Street: two-way traffic flow travelling between the junction with Morgan Street and

the point of road closure at Priory Court.

Schedule 4. Change of Use between 11:00 and 18:00 hours daily:

left of carriageway; Disabled Parking Bay adjacent to Branwen Centre, to **Bridge Street:**

become a temporary Bus Stop.

Bus Stop adjacent to the Cellar Bar and Hairdressing Salon to become Blue **Bridge Street:**

Badge, Disabled Parking

Bridge Street: right of carriageway parking bay; from the point of road closure to the Castle

access road, to become Blue Badge, Disabled Parking

Pendre Permit

Holders Only Blue Badge, Disabled Parking Only.

Car Park:

Schedule 5. Exemptions to this Notice:

Emergency Services(including RNLI and Doctors), Care Providers, Statutory Undertakers(for emergency repairs only).

The alternative route for vehicles to travel around the restricted area from Bridge Street will be to travel the one-way system along Quay Street, Lower Mwldan, Middle Mwldan and Greenfield Square to the junction with Bathhouse Road. From this point vehicles will be able to turn left to access the Medical Centre and the Gwbert Road junction, or turn right to access Pendre, Aberystwyth Road and Feidrfair.

The restrictions are necessary because of likelihood of danger to the public and the need to create 'space' in order to facilitate social distancing by easing the free unfettered movements of pedestrians, due to Covid-19.

This Notice shall continue in force for a period not exceeding twenty one days, after which time its provision may be extended for a further 21 days and/or a temporary Order under Section 14(1) of the same Act.
