

**PUBLIC NOTICE**  
**CEREDIGION COUNTY COUNCIL**  
**TOWN & POLICE CLAUSES ACT 1847**  
**(SECTION 21). TREGAROC 2024**

**NOTICE** is hereby given that the Ceredigion County Council has made the following Order under Section 21 of the Town Police Clauses Act 1847 for the Prevention of Obstruction etc.

**WHEREAS** during certain hours between Thursday 16<sup>th</sup> and Sunday 19<sup>th</sup> May 2024, due to musical celebrations taking place known as TregaRoc, that sections of the road known as the A485, Station Road, from its junction with the B4343 to the Rugby Club, Main Square (outside Y Talbot) Tregaron in the county of Ceredigion, will be thronged and liable to be obstructed. Sections of road known as Maesyrawel and U1504 Tregaron will also be incidentally closed.

Ceredigion County Council pursuant to the powers conferred by Section 21 of the Town Police Clauses Act 1847 DO HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said roads on the said days the following regulations shall be observed:-

1. Subject to those provisions contained in articles 4 and 5, that sections of road known as the A485 Station Road from its junction with the B4343 to the Rugby Club, Tregaron in the county of Ceredigion shall be closed to all vehicular traffic including pedal cycles between 12:00 hours on Saturday 18<sup>th</sup> May 2024 and 09:00 hours on Sunday 19<sup>th</sup> May 2024.
2. Subject to those provisions contained in articles 4 and 5, that sections of road known as the Tregaron Main Square (outside Y Talbot), in the county of Ceredigion shall be closed to all vehicular traffic including pedal cycles between 20:00 hours on Thursday 16<sup>th</sup> May 2024 and 14:00 hours on Sunday 19<sup>th</sup> May 2024.
3. Subject to those provisions contained in articles 4 and 5, that sections of road known as Maesyrawel and U1504 Tregaron in the county of Ceredigion shall be incidentally closed to all traffic including pedal cycles at their junctions with the A485 Station Road between 12:00 hours on Saturday 18<sup>th</sup> May 2024 and 09:00 hours on Sunday 19<sup>th</sup> May 2024.
4. The provisions of article 1, 2 and 3 shall apply only during such times and to such extent as the application of the restrictions referred to therein are indicated by traffic signs and designated stewards.
5. Nothing in article 1, 2 and 3 of this order shall apply to any vehicle being used by the emergency services, vehicles being used in connection with the events giving rise to this order, or anything done with the permission or under the direction of a police officer in uniform.
6. The alternative route for the A485 Station Road closure will be via the C1098 mart road and the B4343 back into Tregaron, a distance of approximately 600 yards. Pedestrian access will be maintained at all times.

The penalty for infringement of the said Regulations is a fine not exceeding One Thousand Pounds.
