DRAFT ORDER

ROAD TRAFFIC REGULATION ACT 1984

CEREDIGION COUNTY COUNCIL (20 MPH, 30 MPH, 40 MPH AND 50 MPH SPEED LIMITS AND DERESTRICTED ROADS) (CONSOLIDATION) ORDER 2014 (GOGERDDAN A4159 AND C1010) (AMENDMENT ORDER NO. 27) 202x

Ceredigion County Council, in exercise of its powers under sections 82 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (“the 1984 Act”), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

1. This Order may be cited as the “Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014 (Gogerddan A4159 and C1010) (Amendment Order No. 27) 202x” and shall come into operation on xx/xx/202x.
2. The effect of the Order shall be to amend the Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014 as amended by the revocation of the plans listed in Column A of the Schedule to this Order and the insertion of the plans listed in Column B of the Schedule to this Order.
3. If a court or the Welsh Government declares any part of this Order to be invalid or unenforceable, such declaration shall not invalidate the remainder of the Order.
