2. **Cau Ysgol Gynradd Gymunedol Dihewyd, Dihewyd, Llanbedr Pont Steffan, SA48 7PN**
3. **Cau Ysgol Gynradd Gymunedol Felin-fach, Felin-fach, Llanbedr Pont Steffan, SA48 8AE; a**
4. **Sefydlu Ysgol Gynradd Gymunedol Ardal newydd, cyfrwng Cymraeg sydd i'w chynnal gan y Cyngor o 1 Medi 2022 ar gyfer bechgyn a merched 3-11 oed gyda cynnydd yn y capasiti i 210 disgybl.**
5. **Y bwriad yw lleoli'r "Ysgol Newydd" ar safle newydd yn Nyffryn Aeron. Rhagwelir y bydd y gwaith adeiladu angenrheidiol wedi'i gwblhau erbyn 31 Awst 2022, ac y bydd yr ysgol yn darparu ar gyfer bechgyn a merched 3-11 oed.**

Cynhelir yr ysgolion gan Gyngor Sir Ceredigion.

- Bydd y ddarpariaeth yn cael ei chadw ar wahân i bob cyfnod allweddol, gyda disgyblion yn cael eu haddysgu mewn dosbarthiadau yn cynnwys llai o ystod oedran
- Byddai ysgol ardal yn gallu ymateb yn well i'r galw am lefydd i ddisgyblion yr ardal
- Byddai gostyngiad yng nghyfarwtaedd y gost fesul disgybl – amcangyfrifir mai'r gost fyddai £3,298

Mae'r Awdurdod yn bwriadu ad-drefnu addysg gynradd yn Nyffryn Aeron a chreu un ysgol gynradd gymunedol newydd, ynghyd â ddarpariaeth feithrin newydd, i gymryd lle'r dair ysgol bresennol. Lleolir yr ysgol newydd ar safle i'w benderfynu yn Nyffryn Aeron ar ôl cael cymeradwyaeth i'r cynnig gan Gyngor Sir Ceredigion.

Gan fod angen codi yr "Ysgol Newydd", bydd angen dal ati i ddefnyddio adeiladau presennol ysgolion Ciliau Parc, Dihewyd a Felinfach hyd nes y bydd adeiladau'r ysgol newydd wedi eu cwblhau, pryd y symudir y disgyblion i'r adeiladau newydd ar y safle newydd. Mae'r trefniadau arfaethedig yn cael eu crynhoi isod:-

- **31 Awst 2022** – Bydd yr ysgolion presennol, sef Ysgolion Ciliau Parc, Dihewyd a Felinfach yn peidio â bodoli.
- **1 Medi 2022** – Bydd ysgol newydd yn agor. Bydd yr holl ddisgyblion yn symud i adeilad newydd yr "Ysgol Newydd" yn Nyffryn Aeron.

Statutory notice to discontinue Ciliau Parc Community Primary School, Dihewyd Community Primary School and Felinfach Community Primary School by Ceredigion County Council, Schools Service, 2nd Floor, Canolfan Rheidol, Rhodfa Padarn, Aberystwyth, Ceredigion, SY23 3UE

Notice is given in accordance with sections 43 and 48 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Ceredigion County Council, having consulted such persons as required, proposes to:

1. **to discontinue Ciliau Parc Community Primary School, Ciliau Aeron, Lampeter, SA48 8BX.**
2. **to discontinue Dihewyd Community Primary School, Dihewyd, Lampeter, SA48 7PN**
3. **to discontinue Felin-fach Community Primary School, Felin-fach, Lampeter, SA48 8AE; and**
4. **to establish a new Welsh Medium Primary Area School to be maintained by the Council from 1 September 2022 for boys and girls aged 3-11 with an increased capacity of 210 pupils.**
5. **It is intended that the 'new school' be located on a new site in the Aeron Valley. It is anticipated that the necessary construction works will be completed by 31 August 2022 and that the new school will cater for boys and girls aged 3-11.**

The schools are maintained by Ceredigion County Council.

The Local Authority undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the proposer's responses and Estyn's full response is available on www.ceredigion.gov.uk.

From 1 September 2022, subject to any expression of parental preference, it is proposed that those pupils registered at Ciliau Parc, Dihewyd and Felinfach Primary Schools and who, but for this proposal, would have expected to attend those schools will be educated at the "New School".

Home to school transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of implementation of the proposal.

In proposing to close the rural schools, the most appropriate response to the challenges highlighted is the implementation of the proposal as presented to create a new area school on a new site in the Aeron Valley and to discontinue the education provision at Ciliau Parc School, Dihewyd School and Felinfach School due to the following factors:

- Provision for key stages will be maintained separately, with pupils taught in closer age range classes
- An area school would be better able to cater for the demand in pupil places within the area
- There would be a reduction in the average cost per pupil at the new area school – estimated to be £3,298

It is proposed to implement the proposal on **31 August 2022**.

Within a period of 28 days of the date on which the proposal was published, that is to say by **13 October 2019** any person may object to the proposal.

EXPLANATORY NOTE

(This Explanatory Note does not form part of the Notice but is offered by way of clarification)

It is the Authority's intention to re-organise primary education in the Aeron Valley and create one new community primary school, together with nursery provision, to replace the three existing schools. The new school is to be located within the Aeron Valley on a site yet to be confirmed upon approval of the proposal by Ceredigion County Council.

As there is a need to construct the "New School", there will be a need to retain the use of the current school buildings until such time as the new school building is complete when the pupils will relocate to the newly built premises on the new site. The proposed arrangements are summarised below:-

- **31 August 2022** – The current Ciliau Parc, Dihewyd and Felinfach Primary Schools will cease to exist.
- **1 September 2022** – A new school will open. All pupils will re-locate to the newly built "New School" in the Aeron Valley.

1. **to establish a new Welsh Medium Primary Area School to be maintained by Ceredigion County Council from 1 September 2022 for boys and girls aged 3-11 with an increased capacity of 210 pupils.**
2. **It is intended that the 'new school' be located on a new site in the Aeron Valley. It is anticipated that the necessary construction works will be completed by 31 August 2022 and that the new school will cater for boys and girls aged 3-11.**

Ceredigion County Council undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the proposer's responses and Estyn's full response is available on www.ceredigion.gov.uk.

It is proposed to implement the proposal on **1 September 2022**. The proposed new school will be a Welsh Medium Community Primary School.

Ceredigion County Council will be the admission authority.

The admission number for 4-5 year olds (reception class) at the new school in the first school year in which the proposal is implemented will be 30.

The new school's pupil capacity will be 210. In addition 60 part-time (3 year olds) nursery places will also be provided.

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of implementation of the proposal.

In the case of the proposal to establish a new community primary school, this will be implemented by the local education authority.

Within a period of 28 days of the date on which the proposal was published, that is to say by **13 October 2019** any person may object to the proposal.
