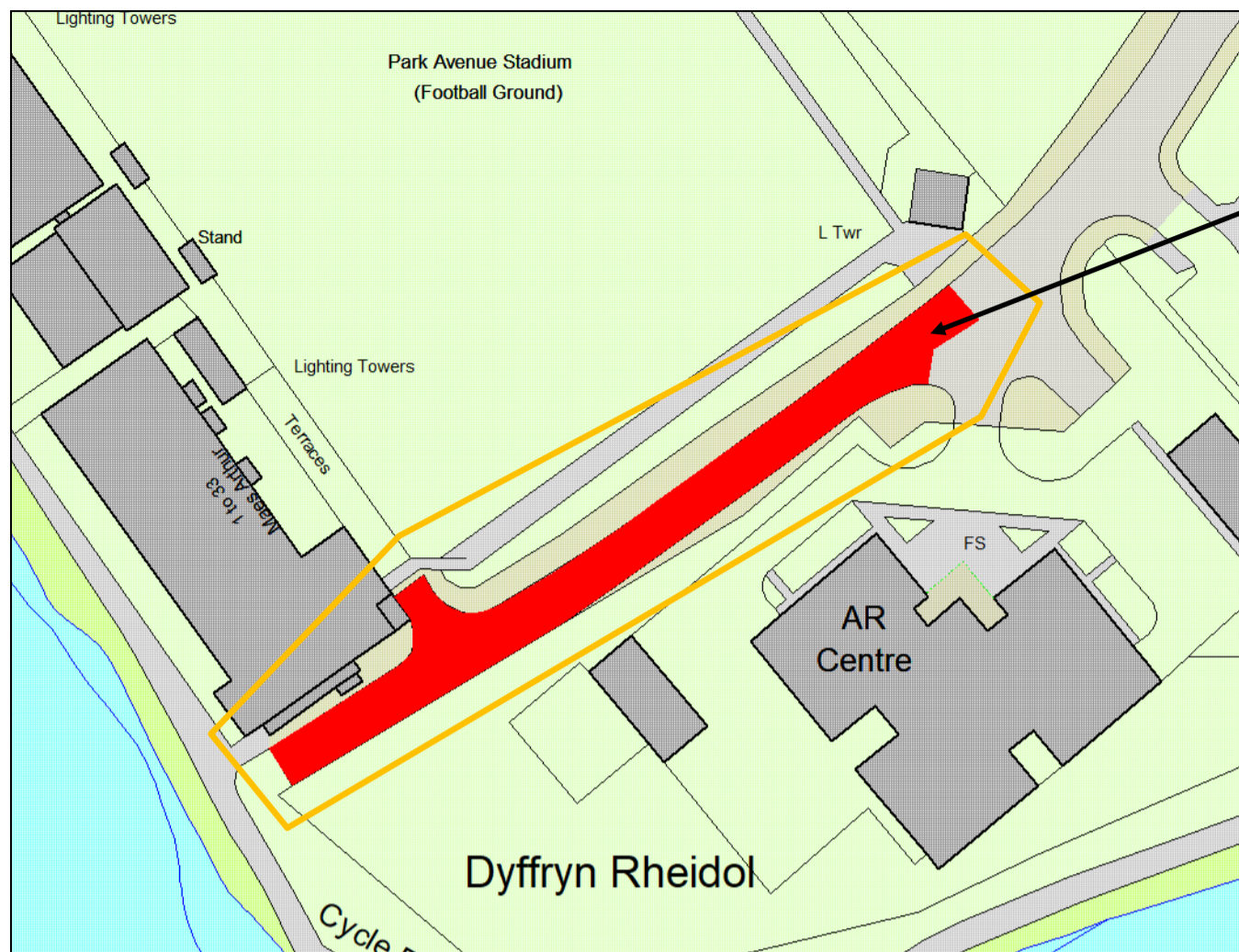

Mae'r Cyngor yn bwriadu gwneud Gorchymyn Cyngor Sir Ceredigion (Gwahardd a Chyfyngu ar Aros a Llwytho a Dadlwytho) 2019 (Maes Arthur, Aberystwyth) (Gorchymyn Diwygio Rhif 18) 202x. Effaith y Gorchymyn hwn fydd cyflwyno Gwaharddiad newydd ar Aros Ar Unrhyw Adeg o bwynt 76m i'r de-orllewin o'r gyffordd â Boulevard St Briec ar ochr ogleddol Maes Arthur, ac o bwynt 81m i'r de-orllewin o'r gyffordd â Boulevard St Briec ar ochr ddeheuol Maes Arthur, i gyfeiriad de-orllewinol hyd at ddiwedd Maes Arthur.

The Council proposes to make the Ceredigion County Council (Prohibition and Restriction of Waiting and Loading and Unloading) Order 2019 (Maes Arthur, Aberystwyth) (Amendment Order No. 18) 202x. The effect of this Order will be to introduce a new Prohibition of Waiting At Any Time from a point 76m southwest of the junction with Boulevard St Briec on the northern side of Maes Arthur, and from a point 81m southwest of the junction with Boulevard St Briec on the southern side of Maes Arthur, in a south-westerly direction to the end of Maes Arthur.
