PUBLIC NOTICE

CEREDIGION COUNTY COUNCIL TOWN & POLICE CLAUSES ACT 1847 (SECTION 21)

ST DAVID'S DAY PARADE, CARDIGAN 2025

NOTICE is hereby given that the Ceredigion County Council has made the following Order under Section 21 of the Town Police Clauses Act 1847 for the Prevention of Obstruction etc.

WHEREAS during certain hours on Friday 21st February, between 09:30 hours and 10:00 hours and then 10:30 hours and 11:00 due to the above event taking place, that sections of the road known as Pendre, High Street, William Street and Priory Street, Cardigan in the county of Ceredigion, will be thronged and liable to be obstructed.

Ceredigion County Council pursuant to the powers conferred by Section 21 of the Town Police Clauses Act 1847 DO HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction on the said road on the said day the following regulations shall be observed:-

- Subject to those provisions contained in articles 3 and 4, the section of road known as Pendre, High Street, William Street and Priory Street, Cardigan in the county of Ceredigion shall be closed to all vehicular traffic including pedal cycles between 09:30 and 10:00 hours and between 10:30 and 11:00 on Friday 21st February.
- 2. The alternative route for north bound traffic from a point east of the closure, at William Street, is to travel on Feidrfair to its junction with Priory Street. Turn right onto Priory Street and travel to its junction with Morgan Street. Turn left onto Morgan Street and continue onto Carrier's Lane and Strand and travel to its junction with Bridge Street. Turn right onto Bridge Street and travel to its junction with Quay Street. Turn left onto Quay Street and travel to its junction with Lower Mwldan. Turn Right onto Lower Mwldan and travel through Middle Mwldan onto Queen's Terrace. Travel on Queens Terrace to its junction with Rhodfa'r Felin/Bath House Road. Turn right onto Bath House Road and to a point north of the closure. Pedestrian access will be maintained at all times.
- 3. The provisions of article 1 shall apply only during such times and to such extent as the application of the restrictions referred to therein are indicated by traffic signs, designated stewards or a police officer in uniform.
- 4. Nothing in article 1 of this order shall apply to any vehicle being used by the emergency services, vehicles being used in connection with the events giving rise to this order, or anything done with the permission or under the direction of a police officer.

The penalty for infringement of the said Regulations is a fine not exceeding One Thousand Pounds.
