

ORDER

ROAD TRAFFIC REGULATION ACT 1984

CEREDIGION COUNTY COUNCIL (20 MPH, 30 MPH, 40 MPH AND 50 MPH SPEED LIMITS AND DERESTRICTED ROADS) (CONSOLIDATION) ORDER 2014

Ceredigion County Council (hereinafter referred to as “the Council”), in exercise of its powers under sections 82 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as “the 1984 Act”), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

PART I – GENERAL

1. CITATION AND COMMENCEMENT

- (a) This Order may be cited as “Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014” and shall come into operation on the 10th day of June 2014.
- (b) The Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014 plans (hereinafter referred to as “the Plans”) listed in the Schedule are incorporated into this Order.

2. REVOCATION

This Order shall revoke all existing permanent orders or parts of permanent orders imposing 20 mph, 30 mph, 40 mph and 50 mph speed limits and removal of restricted road status as they relate to county roads in Ceredigion as defined in previous schedules to these orders made prior to this Order.

3. INTERPRETATION AND DEFINITIONS

- (a) In this Order, except where the context otherwise requires, the following have the meanings hereby respectively assigned to them.
 - (i) “the 1984 Act” means the Road Traffic Regulation Act 1984.
 - (ii) “the Council” means Ceredigion County Council.
 - (iii) “highway” means a way over which members of the public have the right to pass and repass without hindrance and not on sufferance or by licence, the extent of which shall include the carriageway and any footways, verges, roadside wastes or combinations thereof.
 - (iv) “motor vehicle” has the same meaning as that defined by section 136 of the Road Traffic Regulation Act 1984.
 - (v) “Order” means the Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014.
 - (vi) “the Plans” means the Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014 plans listed in the Schedule which are incorporated into this Order.

- (vii) "restricted road" has the same meaning as that defined by section 82 of the 1984 Act.
 - (viii) "road" has the same meaning as that defined by section 192 of the Road Traffic Act 1988.
 - (ix) "traffic sign" means a sign of a size, colour and type prescribed or authorised, or having effect as though prescribed or authorised, under section 64 of the Road Traffic Regulation Act 1984.
- (b) This order relates only to county roads in Ceredigion. Trunk roads and roads in other counties, although shown on some of the Plans, are subject to separate orders.
 - (c) Where reference is made to "Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order" in the Plans, this shall mean the Ceredigion County Council (20 mph, 30 mph, 40 mph and 50 mph Speed Limits and Derestricted Roads) (Consolidation) Order 2014 and its subsequent amendments.
 - (d) For the purpose of this Order, the restrictions and derestrictions contained in the articles to this Order and shown on the Plans shall apply to the full width of the highway.
 - (e) The restrictions and derestrictions imposed by this Order shall be in addition to and not in derogation of any restriction imposed by any regulations or orders made or having effect as if made under the 1984 Act, or by or under any other enactment, including speed limits for vehicles of certain classes as described in Schedule 6 of the 1984 Act, except those orders being revoked in Article 2 of this Order.
 - (f) For the purposes of this Order, the Council accepts no responsibility for any inaccuracies contained in the Ordnance Survey data relied upon in preparation of the Plans. Where a restriction or derestriction applies to a length of highway, that restriction or derestriction will continue to apply to the actual edge of the highway irrespective of changes either to the highway width or to the underlying Ordnance Survey data.
 - (g) Any reference in this Order to a numbered article or schedule shall, unless the context requires otherwise, be construed as a reference to the article or schedule bearing that number in this Order, and any reference to a plan is a reference to a plan incorporated into this Order.
 - (h) The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
 - (i) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
 - (j) For the purposes of this Order, the following shall all be consolidated as 30 mph speed limits made under section 84 of the 1984 Act:
 - (i) 30 mph speed limits on restricted roads for the purposes of section 81 of the 1984 Act.

- (ii) 30 mph speed limits made by restricting a road under sections 82 and 83 of the 1984 Act.
- (iii) 30 mph speed limits made under section 84 of the 1984 Act.

PART II – GENERAL PROVISIONS

- 4. No person shall drive any motor vehicle at a speed exceeding 20 mph on the lengths of road identified as “20 mph” on the Plans attached to this Order.
- 5. No person shall drive any motor vehicle at a speed exceeding 30 mph on the lengths of road identified as “30 mph” on the Plans attached to this Order.
- 6. No person shall drive any motor vehicle at a speed exceeding 40 mph on the lengths of road identified as “40 mph” on the Plans attached to this Order.
- 7. No person shall drive any motor vehicle at a speed exceeding 50 mph on the lengths of road identified as “50 mph” on the Plans attached to this Order.
- 8. The lengths of road identified as “Streetlit sections of road subject to national speed limits (derestricted)” on the Plans attached to this Order shall cease to be restricted roads for the purposes of section 81 of the 1984 Act.
- 9. Nothing in Articles 4, 5, 6, 7 and 8 of this Order shall invalidate any of the exemptions as described in section 87 of the 1984 Act or any part of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.

PART III – VALIDITY

- 10. If a court or the Welsh Government declares any part of this Order to be invalid or unenforceable, such declaration shall not invalidate the remainder of the Order.
